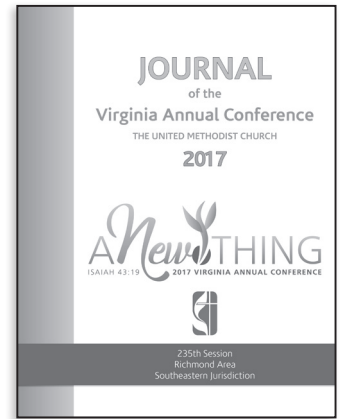

1. The 2017 Conference Journal

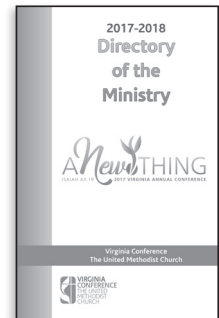
Available three ways:
